The Maritime and Coastguard Agency would like your views on the draft proposals for the 2026 edition of the Code of Safe Working Practices for Merchant Seafarers (COSWP). All amendments are <u>HERE</u> (Chapter 19) and <u>HERE</u> (Chapter 18) tracked changes visible, please see Annex 1 for a summary of these changes.

SNC Survey

The UK Hydrographic Office has opened a short consultation on the use of their future Paper Chart service: to make sure that their offering is current and detailed in the right way, they want to shape developments to their paper chart service. At the heart of this is their commitment to support the paper chart user whilst a navigational need for paper charting remains. In order to do that they have to evolve the service to make sure it's sustainable for us to meet that need.

The questions in the survey will give them the information they need to understand what mariners are currently, and in the future, using paper charts for and how.
