Line of fire injuries occur when a person is struck by moving objects or hazardous energy, and they remain the leading cause of lost time injuries among IMCA marine contractor Members in 2024, accounting for 52% of cases. This month, the Marine Working Group highlights key tools and resources to help reduce these incidents, including Learning Event Bulletins, Safety Alerts, and dedicated Line of Fire and Hands and Fingers safety portals. What did the Budget ever do for us?

In short: This year's Budget did not deliver anything specifically for small commercial vessels, but it set the stage for indirect benefits via ports and "green infrastructure" investments. The challenge will be ensuring the small vessel industry is not overlooked in its implementation.

Yesterday's UK Budget (26 November 2025) offered limited measures for maritime. But indirectly it did include port investment zones, energy transition incentives, and operational cost pressures.

- · Industrial Strategy Zones & Port Investment
 - New Industrial Strategy Zones in Wales and Scotland, plus co-investment in Northern Ireland, include port and logistics infrastructure.
 - This could mean improved facilities and funding streams for harbour upgrades, which directly benefit workboat operators through better access, maintenance, and energy supply points.
- · Energy Transition & Decarbonisation
 - The Budget reaffirmed commitments to green growth and local energy investment. While not vessel-specific, this aligns with ongoing support for electrification and alternative fuels.
 - Small Commercial Vessels may be able to benefit from grants or tax relief tied to clean energy adoption, especially if linked to port-based battery swap or hydrogen bunkering schemes.
- · Operational Costs & Taxation
 - Negatively: Rising corporation tax and reduced financial allowances could squeeze margins for small businesses further
 - Fuel duty remained unchanged and no new relief was offered for marine gas oil or biofuels

Vision for a new Maritime Innovation Hub for Scotland

Scottish Enterprise is running a feasibility study for a potential Scottish Maritime Innovation Hub and is seeking input from maritime sector stakeholders.

The hub would support the maritime sector and wider supply chains in adopting new technologies, connecting industry, academia, logistics and technology to drive trade, safety, sustainability and innovation.

New MCA Guidance: The Port Marine and Facilities Safety Code

The Port Marine and Facilities Safety Code is applicable to both Statutory Harbour Authorities and to other marine facilities which may not have statutory powers and duties.

The Code is endorsed by the UK Government, devolved administrations and representatives from across the maritime sector and while the Code is not mandatory, these bodies have a strong expectation that anyone who manages ports and other marine facilities will incorporate the relevant requirements of the Code into their safety management and other systems.

The following information provides the PMSC compliance requirements for the period 2026- 2028. Every three years the Duty Holder of Statutory Harbour Authorities (SHAs), private ports, and other marine facilities is requested to make a declaration to the MCA confirming their organisation's PMSC compliance.
